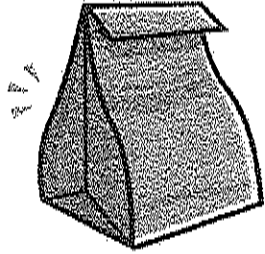

Lunch Buddies

We are starting up a Lunch Buddy Program at Edmonds Elementary and would love to have your help! We are looking for caring and conscientious adults who are willing to spend some time each week with one or two of our elementary students.

Many of our students need positive role models and someone who is special to them. Lunch Buddies offer the students and adults an opportunity to enjoy each other's company. Additionally, students have an opportunity to develop better communication skills, build positive relationships and increase self-esteem.

Typically, Lunch buddies would come and eat lunch at the school once a week. The Lunch Buddy picks one day a week that is convenient for them and enjoys lunch with a student. After lunch, Lunch Buddies and the students might enjoy playing a game, reading together, doing a craft or just hanging out.

Our lunch and recess times are 11:20-12:00 for grades K-3 and 11:45-12:25 for grades 4-6. Other schools in the Edmonds School District have enjoyed this program for many years and the Lunch Buddies that have been involved report the experience as being more beneficial to them than to the students.
